

# Tehama County Department of Education

## Transportation Plan

### 2023-24

#### Transportation Services:

1. Enter description of transportation services offered to pupils, and how the LEA will prioritize planned transportation services for pupils in transitional kindergarten, kindergarten, and any of grades 1 - 6 inclusive and pupils who are low income. The Plan may provide for the LEA to partner with municipally owned transit system to provide services to middle and high school students. An LEA may provide no-cost transit passes to students.

Tehama County Department of Education (TCDE) offers transportation to students with disabilities attending regional programs authorized by the Governing Board of the Special Education Local Plan Area (SELPA). Students who attend Tehama County Department of Education (TCDE) regionalized programs are offered transportation as a related service within their Individualized Education Plan (IEP). Transportation is offered to any student attending these programs at no cost to families. The following grade spans are served within the regional programs: Pre-School, TK-8th grade, and Postsecondary Adults, 18-22. Students are picked up from their residence and transported directly to their program's site. All costs for this program are absorbed through Tehama County Department of Education's transportation allocation as well as a fee for service from the district of special education accountability of each student accessing a TCDE regional program, through the SELPA expense model.

2. Enter description of LEA's transportation services that would be accessible to pupils with disabilities, and homeless children and youth.

TCDE provides transportation to students with disabilities, enrolled in a regional TCDE program, as defined by the Special Education Local Plan Area (SELPA), in a variety of way through ADA compliant buses and vehicles and meet the individual and geographical needs of each student, based on their IEP team recommendations. If van or bus transportation is not appropriate or feasible for the student based on their needs and as a result are transported to the regional program by their family, reimbursement to the family at the federal mileage rate is provided. Additionally, if there is capacity and common geographical routes, TCDE will partner with smaller LEAs in Tehama county, to offer transportation, specifically to any student with a disability accessing another district program, at no cost to the family. If a student is a foster youth, unhoused, or transient, the TCDE continues to transport students with disabilities to the regional program at no cost to the family.

3. Enter description of how unduplicated pupils would be able to access available home-to-school transportation at no-cost to the pupils.

Any student enrolled in a TCDE regional program, as defined by the SELPA (preschool, K-8, and post-secondary (18-22 year old students on IEPs in regional programs), has access to home to school transportation at no cost to the family.

#### Consultations:

Tehama County Department of Education, through the SELPA Governing board, consults with all district Superintendents on regionalized transportation, monthly, in a meeting also open to the public. The Tehama County SELPA also consults with the Community Advisory Council (CAC), made up of primarily parents of students with disabilities, quarterly, open to the public. The Tehama County SELPA consults with other partner agencies regularly such as the Regional Center and Rowell Family Empowerment Center, to ensure family voice is considered. Every student offered transportation has at least one, if not more, Individualized Education Plan meetings per year, to discuss the offer of education, including transportation, at no cost, with the family and all staff involved in the child's educational plan. Additionally, TCDE administration meets regularly with their bargaining units and discusses transportation needs. Our Director of transportation oversees our fleet and has daily contact with TCDE Special Education leadership and regular contact with families of students receiving transportation as a related service. The geographical span our transportation department is required service for students with disabilities does not have any regional local transit authorities. TCDE Administration and Director of Transportation will continue to work with air quality management district to ensure our fleet is maintaining best practice emissions and adhering to all requirements.
